The Ministers of the Welsh Assembly Government have appointed **Mr Alwyn Nixon BSc(Hons)**, **MRTPI** of the Planning Inspectorate to conduct the Examination which will include a series of Hearings which will commence on **Tuesday 2 February 2010**.

The aim is to allow the Inspector to conduct a structured exploration of the issues arising, to assist his consideration of the Plan's soundness.

The Inspector has asked me to draw your attention to the fact that **representations made in writing carry the same weight as those pursued by a personal appearance at any of the Hearing sessions**. In this respect, if you have now changed your intention as regards appearing in person or have decided to withdraw your representation, please indicate accordingly on the reply slip.
